88-89	Redacted	BP Executive Summary of Weekly Events for Blaine Sector	Notes that Sumas agents arrested 2 adult Mexicans and took custody of their 2 USC children during a translation assistance call for Whatcom County Sheriff's Dept.
90-93	Redacted	National Native American Affairs Program Report: Blaine Sector	Notes that Blaine BP agents responded to two requests for translation assistance, one from the La Push Tribal Police and the other from the Tulalip Nation Police. In both instances, subjects were found to be unlawfully present.
94-99	Redacted	National Native American Affairs Program Report: Blaine Sector	Notes that Blaine BP agents responded to a translation request from the Lummi Nation Police about a domestic violence dispute. Agents provided translation assistance and took into custody a Mexican man found to be unlawfully present.

"Agents providing translation assistance and law enforcement back-up, help maximize and enhance the Neah Bay Tribal Law Enforcement and Natural Resources Management capability, reducing crime in border communities and safeguarding the environment on Makah tribal lands while building strong law enforcement partnerships." Also mentions that Bellingham Station BP frequently interacts with Lummi Nation Police and responds to all requests of translation assistance.
